MEMORANDUM OF UNDERSTANDING BETWEEN SHANXI CONSERVANCY TECHNICAL INSTITUTE, CHINA

FACULTY OF ENGINEERING, RAJAMANGALA UNIVERSITY OF

TECHNOLOGY LANNA, THAILAND

Memorandum of Understanding

In order to strengthen the cooperation between the China and Thailand and Shanxi Conservancy Technical Institute in China and Faculty of Engineering, Rajamangala University of Technology Lanna in Thailand, through friendly discussion, the two sides have come to an agreement, and agree to sign this Memorandum of Understanding. The specific affairs concerned come to agreement as follows:

- I. The two parties agree to establish friendly intercollegiate relationship, and promote personnel exchanges, the mutual understanding, and the development of academic and culture exchange between the two institutions.
- II. The two parties agree to arrange exchange visits for college-level delegations according to the needs, and coordinate the cooperative affairs.
- III. The two institutions agree to cooperate and carry out the project cooperation based on International colleges established by each as follows:
- 1. The project of exchanges for the students of the two parties. The two parties organize students to go to each other to take short-term learning, training and practice.
- 2. The project of teaching exchanges for teachers according to the needs of teaching, the two parties can exchange teachers to promote the academic teaching performance between Chinese and Thai.
- 3. The project of bilateral academic exchange activities both parties will carry out bilateral academic exchange activities, such as culture exhibition, skills contest viewing, visiting the enterprise, task survey, and international conference, etc.



- 4. Both parties agreed to carry out project co-cooperation on the following specialty major: computer, cloud computing, e-commerce, high-speed railway passenger transportation, high-speed rail signal direction, railway communication and information technology, communication technology.
- 5. This MOU only expresses the intention of cooperation. It has no legal effect on both parties.
- 6. This MOU will remain in effect for five years from the date of signing, and is renewable thereafter for five-year terms subject to mutual consent. This MOU may be terminated by either party by giving at least six months' notice in writing to the other party.
- IV. This Memorandum of Understanding is written in Chinese and English, In case of any discrepancy between Chinese and English versions, the English version shall prevail. Each side is taking one copy.

- 6.本谅解备忘录自签署之日起五年内有效,经双方同意后可续签五年。任何一方至少提前六个月向另一方发出书面通知,即可终止本谅解备忘录。
- IV.本合作谅解备忘录用中英文书写,如中英文版本不一致,以英文版本为准, 双方各持一份。
