



**Memorandum of Understanding
Between
Rajamangala University of Technology Lanna (RMUTL)
And
Copartner Technology (Thailand) Co., Ltd.**

This Memorandum of Understanding (MOU) is made on 4 July, 2024, between Rajamangala University of Technology Lanna (RMUTL), located at 128 Huay Kaew Road, Mueang, Chiang Mai, Thailand, represented by Assoc. Prof. Wichet Thipprasert, and Copartner Technology (Thailand) Co., Ltd., located at 500/165, Moo 3, Rayong WHA1, Tasit, Pluak Daeng, Rayong, Thailand, represented by Mr. Wu, Kan – Chu.

Purpose:

This MOU aims to foster collaboration between Rajamangala University of Technology Lanna (RMUTL) and Copartner Technology (Thailand) Co., Ltd. The focus is on developing faculty expertise, enhancing academic curricula to meet industry needs, and providing students with professional internship opportunities to better prepare them for the workforce.

Areas of Cooperation:

The cooperation may include, but is not limited to:

1. Development of mutually beneficial academic and training programs.
2. Training and professional development programs for faculty members.
3. Joint development of modern curricula aligned with industry demands.
4. Internship programs and other skill-enhancing activities for students to gain professional experience within the company.

Financial and Implementation Arrangements:

Each party understands that any subsequent financial arrangements will be negotiated on an activity-by-activity basis, subject to the availability of funds. Specific details for implementing these activities will be mutually developed for each project. Annexes may be added to this MOU over time to outline specific projects and financial arrangements.

Duration and Termination:

This MOU is effective for a period of five years and may be renewed upon mutual agreement by both parties. Either party may amend, extend, or terminate this MOU at any time by mutual consent or with six months' written notice to the other party.

Dispute Resolution:

Any disputes arising from the implementation of this MOU will be jointly resolved through negotiation and conciliation, in the spirit of cooperation, goodwill, and mutual benefit.

This MOU comprises two identical copies, each containing the same content. Both parties have thoroughly reviewed and understood the terms. Therefore, they have signed the document in the presence of witnesses, with each party retaining one signed copy of the Memorandum of Understanding.
